Note: This form must be read and signed before the Put-In-Bay Grass Volleyball Player, Staff and any personnel, listed below is allowed to take part in any set-up, training, competition, practice/warm up sessions, and meeting or testing sessions. I hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns: a) **I WAIVE, RELEASE, AND DISCHARGE** from any and all claims or liabilities for death or personal injury or damages of any kind, which arise out of or relate to my participation in, or my traveling to and from this volleyball event, **THE FOLLOWING PERSONS OR ENTITIES:** The City of Put-In-Bay, The Mayor of Put-In-Bay, any Property Owners & Family along with any Business('s) associated in the use or renting of property, The Tournament Director(s) & Staff, Sponsors; and the officers, directors, employees, representatives, and agents of any of the above; b) **I AGREE NOT TO SUE** any of the persons or entities mentioned above for any of the claims or liabilities that I have waived, released or discharged herein; and c) **I INDEMNIFY AND HOLD HARMLESS** the persons or entities mentioned above from any claims made or liabilities assessed against them as a result of my actions.
